- 1. Memory leak and crash issue in Billing review. This was fixed
- 2. QuickBooks Realtime Sync error (BQ-911). This was fixed
- 3. Report List disappear randomly. This was fixed

- 6. Payments made in QuickBooks using credit card when synced into BillQuick are displayed as check. This was fixed
- 7. In certain cases, deleting synced expenses breaks project link with QuickBooks. This was fixed
- Billing Review (BQ-740) Project has Fixed Contract type. Under Billing rules 'Use Billing Schedule Reminder Date' is checked. On processing bill user gets incorrect message. This was fixed
- 9. Performance issue in Billing Review (BQ-773)
- 10. Time Entry billable status was changing randomly for several contract types(BQ-782) This was fixed
- 11. Draft Invoice Process to Final not following Sequence set in Global Settings(BQ-803) This was fixed
- 12. Submitted expense performance issue in Home screen. This was fixed

### List of Items addressed in release 18.0.7.4 August 11, 2017

 When posting invoices in the Invoice Review screen, application returns an error message. The error goes away after clicking on the OK button on the message, invoices do get posted and PDF also are created by the application.

### List of Items addressed in release 18.0.7.2 August 7, 2017

- 13. In certain cases memo tied to time entries disappear from Simple Time Card. The memo indicators were also not displayed if a memo existed for a time entry. This was fixed.
- 14. Memo of previous Vendor Bill was carried forward. If a new Vendor Bill was created.
- 15. Search of Project Center was not functioning properly. This was fixed.

- 16. In certain cases the Write Check Screen was displaying wrong information in Pay to the order of field, if a negative amount was applied as retainer from Payment screen.
- 17. BillQuick application incorrectly calculates the total amount of Expenses of an Estimate assigned to the project. When the Estimate is viewed in cumulative mode.
- 18. Incomplete time entries in Sheet View were getting erased when invoices are processed in Billing Review.
- 19. In certain cases billable flag was set for non-billable entries if the rule Time Entry Memo required was checked. This was fixed.
- 20. Date ranges in Manual Invoice sometimes displayed dates of next month for projects that were never billed.
- 21. Expense Log doesn't allow cost rate of \$9,999,999.99. This was fixed.
- 22. While submitting a PTO request application is unable to pull CC and BCC fields from Global Settings. This was fixed
- 23. Application is unable to update time entries for projects having rule Lock at Contract Amount applied. This was fixed.
- 24. In certain cases the application was unable to reuse saved statement reports.
- 25. In certain cases Billing Review does not respect project group filters for unapproved time and expenses.
- 26. Change utility allows to change the project identifier of billed time and expense entries.
- 27. In certain cases drafted reconciliations were not removed from the application.
- 28. When a bounced check is recorded in the application for a project which has a class associated throws error.
- 29. Emails sent from statement preview does not respect global settings.
- 30. Sometimes the application does not include all attachments with an invoice when are sent through email.
- 31. Incorrect contact email fetched in CC field of email when user selects multiple invoices of different clients.
- 32. Fixed security issues related to report permissions.
- 33. In certain cases date time formats are not respected in Simple Time Card for Canadian regional settings for entries which have comp time detail frequency set as semimonthly.
- 34. "Profit & Loss Accrual Previous Year Comparison" report does not take applied filters if we drill down it further.
- 35. Manual Invoice expense amount does not respect group options.
- 36. Last Invoice number is not respected in case of draft invoices.
- 37. In certain cases top 10 employee's widget displays duplicate employees.
- 38. Licensing and User Managements sometimes does not reflect changes on refresh.
- 39. Payments made in QuickBooks using credit card when synced into BillQuick are displayed as check.
- 40. In certain cases deleting synced expenses breaks project link with QuickBooks.
- 41. Exporting invoices to LEDES format sometimes does not respect currency symbol.
